\$10,000,000
Settlement

(IL, Champaign 6th Jud Cir) Pltf presented to the ER with numbness and sudden loss of motor function on the left side of her body. Deft allegedly discharged her without ordering a neurology consult or an MRI. Later it was discovered that pltf was having a stroke.

\$9,872,232
Verdict

Settlement

(IL, Champaign 6th Jud Cir) During construction, defts failed to provide lifelines, guardrails, safety nets, and other forms of fall protection. Pltf fell 30 feet resulting in disabling closed head injury which left him unable to move, speak, or feed himself.

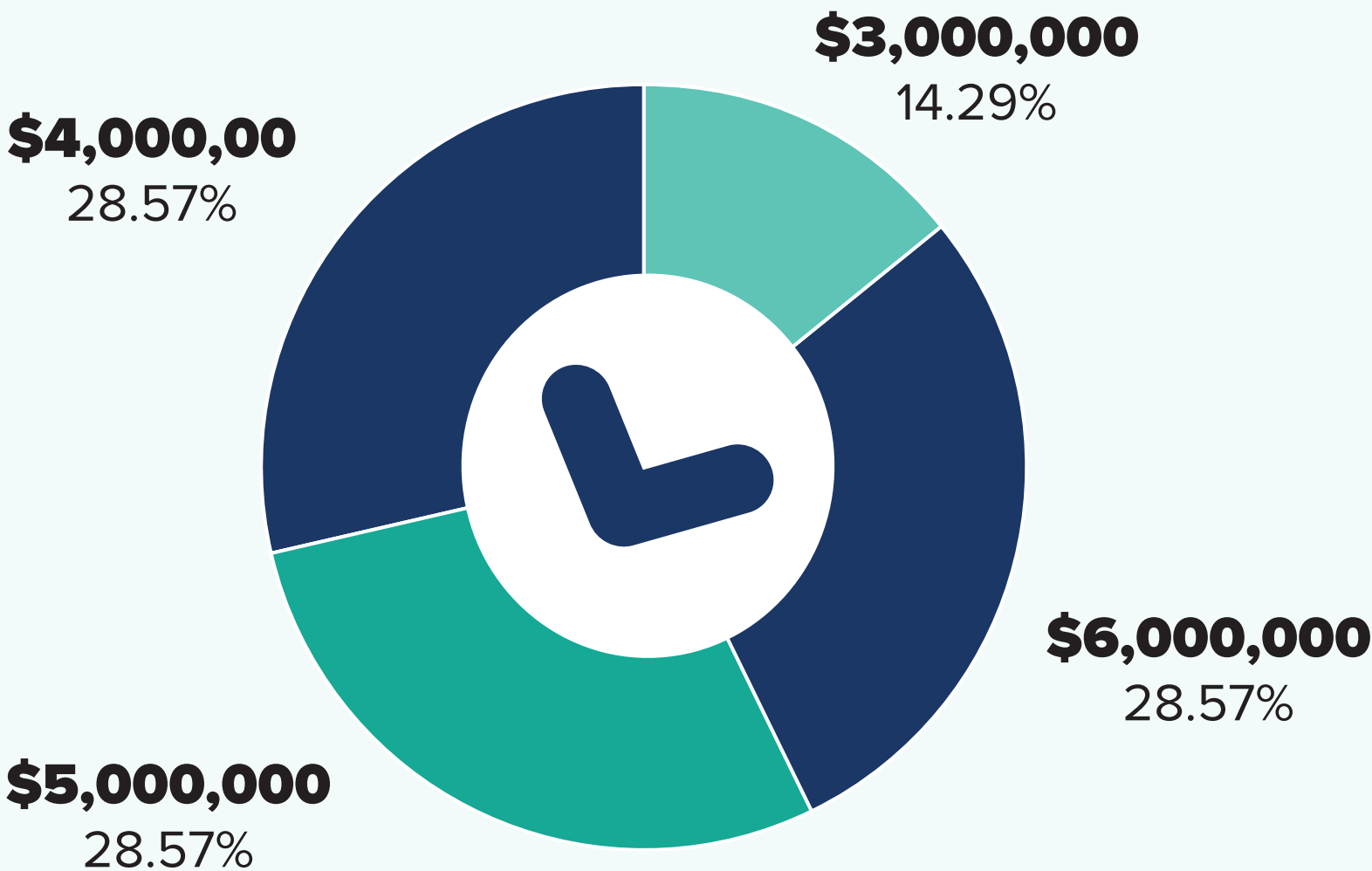
